As per 2256303 Ontario Ltd, o/a Blue Sky RV Resorts ("the Resort") Rules & Policies, and Provincial Law, I agree to following rules regarding my ATV:

1. All provincial road laws, the motorized vehicle act, municipal by-laws and Trespass to Property Act must be obeyed at all times.
2. Anyone operating an ATV must have a current driver's license and proof of insurance. They must be a minimum of 16 years old. Passengers of ATVs must be a minimum 8 years old, and be able to touch the pedals.
3. ATVs are not allowed to be used in and around the resort, but can be used to go to and from the trails.
4. ATVs cannot be used during quiet hours (11pm – 8pm).
5. ATVers must follow all provincials laws and the rules of the OFATV.
6. Maximum of 2 ATVs can be parked on a campsite.
7. All ATVers must show proof of insurance.
8. All ATVers must show proof of OFATV trail pass or purchase one from the office.
9. ATV driver and passengers must wear helmets.
10. ATVs must abide by Resort speed limit of 10km/hr while in the Resort.
11. ATVs and ATV trailers must be parked in designated areas when requested by management.
12. Failure to follow the above rules will lead to immediate expulsion from the Resort with no refunds of seasonal or overnight fees.
